# NORTH CAROLINA STATE FLORISTS ASSOCIATION Board of Officers and Directors Meeting | Embassy Suites, Greensboro, NC | April 14, 2013

President Wayne Burchett called the meeting to order at 9:30 AM with the following in attendance:

President Burchett asked all board members to re-affirm the Anti-Trust Policy.

<u>Treasurers Report</u> – Bud Cardwell presented the financial statement as of 3-31-13. Gary Corsi O'Connor made a motion to accept as presented, second by Joe Davoli. Motion carried.

<u>Education</u> — Bill McPhail reporting for the Education Committee gave an update of how many people had taken on-line classes since the beginning of the year. McPhail also stated that Pat Murray had agreed to pay to have flyers copied about the NCCPF School. Flyers will be distributed to the wholesalers for distribution to customers.

<u>AIFD Symposium Registration – AIFD</u> has given to the NCSFA a free registration to AIFD to be held in June. Two people applied for registration. By vote of the NCSFA board, the free AIFD registration was given to Brandi Dennison. If Ms. Dennison is not able to attend, the registration will be given to Janet Blackard. <u>Membership</u> – Charlie Jordan stated that this is not solely the job of the membership committee. Jordan encouraged all board members to invite someone to be a member and encourage them to attend the convention. <u>Rules and Policy</u> – Gary Corsi Oconnor presented the following recommendations from the Rules and Policy Committee

Section 16 -

Judging/Tabulations

- III. Tabulation Criteria/ Responsibilities
- A. Tabulation Chairman shall be appointed by the President. The chairman shall select a committee to assist. President shall appoint a committee of a minimum of three persons to tabulations. The President will appoint a chairperson of tabulations from within the committee. Besides the three persons serving on the committee, there will always be a fourth alternate to be called upon during convention. If anyone on the committee is related to or is employed or works with someone who has entered the competition, or if a committee member is entering a competition, they must excuse themselves from tabulating that competition and the alternate will be used to tabulate the scores for that competition.

Cheri Burchett made a motion to accept recommendation, second by Charlie Jordan. Motion carried.

- III. Tabulation Criteria/ Responsibilities
- G. The judging sheets used will be as created by Pat Murray AIFD for all of the competitions (as of 1/20/13) with the exception of Treadaway Cup and NC Dogwood Cup. (The judging sheet decided upon at later time.). Cherie Burchett made a motion to accept recommendation, second by Jim Tysinger. Motion carried.
