Not in attendance: Jim Tysinger, Jennifer Childers, Sarah Allen, Charita Walker, Jay Curtis, Lona McKinney President OConnor asked all board members to re-affirm the Anti-Trust Policy.

<u>Treasurers Report</u> – Bud Cardwell presented the financial statement as of 5-31-14. Joe Davoli **made a motion to accept as presented**, second by Wayne Burchett. Motion carried.

Nelson Simpson made a motion to set membership dues at \$95 for both active and associate members effective October 1, 2014, second by Cherie Burchett. Motion carried.

Bylaws – No report.

<u>Convention</u> – President OConnor gave an overview of the convention. Cherie Burchett made a motion to set the convention registration fee for 2014 at \$175, second by Sarah Callahan. Motion carried.

Education – Sherri Suttle was unable to attend and submitted the following education committee report.

#### **Education Committee Report:**

A. The education committee was in charge of collecting applications for the free general AIFD registration. The first deadline was March 31. We had no applicants before this time. The second deadline was April 17. During this time we had one applicant, Don Holmes, to apply. We do realize Don is on the education committee; however, when I received the application from Don I talked with Gary and we decided to open this opportunity up to the entire board. No one else applied before the April 17 deadline. It is the education committee's recommendation that Don Holmes be awarded the free general AIFD registration to the AIFD national symposium in Chicago.

B. The education committee did a NCCPF Master exam on Saturday,

March 1 at Always and Forever Florist in Madison. We had three students to Test, and all three passed. We plan on pinning these students at the Convention in August.

C. The education committee is planning to offer another NCCPF Master

Exam on Friday August 15, at the beginning of Convention, at the Embassy Suites.

D. The education committee is working on a potential workshop to be held after the board meeting in June. Details later.

The education committee will be meeting to discuss raising the cost of the master exam to cover the cost of the flowers we have to procure. This has been the cost for of the master exam for some time, and we have not raised the cost even though flower cost has increased.

<u>Rules and Policy</u> –President OConnor reporting on behalf of Rules and Policy submitted the following change to the TAPS section 16 of Rules and Policy. (underlined items below will be deleted from rules and policy)

- Criteria
  - B. Trophies will be awarded only for 1<sup>st</sup> place awards and certificates will be awarded for 2<sup>nd</sup> and 3<sup>rd</sup> places in all competitions. <u>Unless otherwise specified in contest rules</u>
    <u>Items listed below (underlined) will be deleted from rules and policy.</u>
  - C. Trophies, Awards and Presents will be presented for the following:
    - 1. Designer of the Year: Winner, first runner-up, and second runner-up. Each will receive a trophy
    - 2. Centerpiece: first and second.
    - 3. <u>Body Flowers:</u> First and second if five or more entries. Less than five, only first.
    - 4. <u>Basic Body Flowers: Winner and runner-up certificates.</u>
    - 5. Headdress: First and second if five or more entries. Less than five, only first.
    - 6. <u>Basic Headdress: Winner and runner-up certificates.</u>
    - 7. <u>Talent: First and second for two categories of serious and comedy, if five or more entries in each category. If less than five, only first.</u>
    - 8. Miniature: first, second, and third.
    - 9. Mask: first and second if five or more entries. Less than five, only first.

Motion made by Wayne Burchett to accept the above change as presented by rules and policy, second by Brandi Dennison, motion carried. (items above underlined will be deleted)
